WE, THE UNDERSIGNED, all citizens of the United States and a majorit citizens and residents of the District of Columbia, desiring to associate ourselves as a corporation pursuant to the provision of Title 29 of Chapt 6 of the District of Columbia code (1940), do hereby certify as follows:

First. The name or title by which this corporation shall be known i law shall be The Wildlife Society, Incorporated.

Second. The term for which it is organized shall be perpetual.

Third. The particular business and objects of said corporation shal be the: (a) Establishment of professional solidarity and maintenance of the highest possible professional standards; (b) development of all types of wildlife management along sound biological lines; (c) publications to effect these ends; and (d) protection of the interests of its members. These purposes are served by annual meetings, regional meetings, correspondence between members, and publication of the quarterly Journal of Wildlife Management and the quarterly Wildlife News Letter. The corporation shall function as an educational and scientific society. It shall be a non-profit corporation and without capital stock.

Fourth. The number of managers, members of the Council or Executive Committee for the first year of its existence as a corporation shall be eleven. The names and addresses of the members of the Council or Executive Committee until its next annual election are:


